### **MANDATORY RULES**

- 1. Every decision is at unquestionable discretion of the teachers.
- 2. Students must be present for the whole day and every day, otherwise the certificate will not be issued and will not be possible to sing and participate at the final concert.
- 3. The singers who will participate in the final concert will be selected at the discretion of the artistic staff.
- 4. None of these payment will be given back or refunded, not even partially, in case of waiver by the applicant.
- 5. In case of missing conditions for the starting of the Workshop the paid registration fee will be returned.
- 6. OttavaNota and Accademia Lirica Cantoalato are not responsible for any suspension of activities for reasons beyond their will; in case the Workshop could not be carried out on the dates indicated, however, it will be postponed and new dates will be communicated promptly. As the Workshop will take place, the refund of the registration and/or attendance fee cannot be requested.
- 7. Accademia Lirica Cantoalato and OttavaNota hold the distribution and use rights of audio recordings, videos, publications and/or other related to the Workshops.
- 8. Recordings (audio or video) of the lessons are allowed, exclusively for personal use. By signing the Application Form of the Workshop you accept the explicit clause of not broadcasting audio or video by any means or any tool.
- 9. Payments can be made in cash, credit card, ATM, cheque or Satispay, or bank transfer.



#### POLICY ON THE TREATMENT OF PERSONAL DATA

Pursuant to Article 13 of the GDPR (EU) 2016/679, OttavaNota Association, as Data Controller, with this information we intend to provide a series of information regarding the modalities of protection of personal data.
