## **MANDATORY RULES**

- 1. Every decision is at unquestionable discretion of the teachers.
- 2. The audio or video recordings required for the selection of the Opera Studio participants, will not be distributed or published and will be for the exclusive use of the Accademia Cantoalato. The only recordings authorized for public use will be made by the organization of the Accademia Cantoalato-OttavaNota.
- 3. Students must be present for the whole day and every day, otherwise the certificate will not be issued and and will not be possible to sing and participate at the final concert.
- 4. None of these payment will be given back or refunded, not even partially, in case of waiver by the applicant.
- 5. In case of missing conditions for the starting of the Opera Studio, the paid registration fee will be returned.
- 6. OttavaNota and Accademia Cantoalato are not responsible for any suspension of activities for reasons beyond their will; in case the Opera Studio could not be carried out on the dates indicated, however, it will be postponed and new dates will be communicated promptly. As the Opera Studio will take place, the refund of the registration and/or attendance fee cannot be requested.
- 7. Accademia Cantoalato and Ottavanota hold the distribution, dissemination and use rights of audio recordings, videos, publications and/or other related to the Opera Studio
  - Pictures and video material of the concert that will be provided to participants, is at their disposal, with free use: it remains the obligation to mention in every communication (social or other) the ACCADEMIA CANTOALATO.
  - It remains beyond the obligation to indicate the name of the conductor and director in the photos/videos in which he appears.
- 8. Recordings (audio or video) of the lessons are allowed, exclusively for personal use. By signing the Application Form of the Opera Studio you accept the explicit clause of not broadcasting audio or video by any means or any tool.
- 9. Payments can be made in cash, credit card, cheque or Satispay, or bank transfer.



## POLICY ON THE TREATMENT OF PERSONAL DATA

Pursuant to Article 13 of the GDPR (EU) 2016/679, OttavaNota Association, as Data Controller, with this information we intend to provide a series of information regarding the modalities of protection of personal data. Associazione OttavaNota collects and treats such data, contained in the registration form to the Opera Studio and to the OttavaNota association, for the institutional purposes indicated on the card. The personal data collected:

- they are treated for the formalization and consequent organizational, administrative, legal and fiscal management of the contractual relationship that comes from the acceptance from OttavaNota of the adhesion to the association and registration to the Opera Studio; - are processed in electronic, computer and paper mode by internal staff, authorized collaborators and external data processors duly appointed by OttavaNota; - stored on computer or paper and protected from unlawful or unauthorised access, theft, loss and destruction by appropriate security measures.

The personal data will be kept for 10 years from their acquisition. As an interested party, as provided by art. 13 of GDPR (EU) 2016/679, OttavaNota may request access to personal data, rectification, deletion of personal data or limitation of processing. You also have the right to data portability as well as the possibility to complain to the Authority Guarantor for the protection of Personal Data.
